The Foundation does not comply with this recommendation. The Foundation fundamentally disagrees with the idea of setting an absolute date of retirement. Age in and of itself should not be a disqualifying factor when evalu- ating the competences of board members. The Foundation has therefore declined to set an abso- lute age limit. However, Board members having reached the age of 70, will now be elected by dis- pensation for a term of two years rather than four years cf. the Foundation Charter Article 8A www.poulduejensenfounda- tion.com/charter

All information regarding remu- neration is available to the Danish Business Authority as well as to the Board upon request. In addition, according to the pro- visions in the Financial State- ments Act, remuneration of board members and the management of a foundation can be disclosed en bloc in documents with public ac- cess. The Foundation prefers to apply the rules in the Financial Statements Act in this regard.
